4. Responsible Internet Use

*ICT, including Internet, email and mobile technologies, etc. is an important part of learning in our school. Pupils have **controlled** access to the Internet and learn how to use libraries, databases and information sources on a wide variety of topics. We use a filtered service provided through East Sussex County Council, which regularly monitors websites and automatically blocks access to inappropriate material.*

We expect all children to be safe and responsible when using any ICT. Please read and discuss with your child the eSafety rules below:

Responsible Use of the Internet/e-Safety Rules

- ✓ I will only use ICT in school for school purposes
- ✓ I will not tell other people my ICT passwords
- ✓ I will only open/delete my own files
- ✓ I will make sure that all ICT contact with other children and adults is responsible, polite and sensible.
- ✓ I will not deliberately look for, save or send anything that could be unpleasant or unkind. If I accidentally find anything like this I will tell my teacher immediately
- ✓ I will not give out my own details such as my name, phone number or home address.
- ✓ I will be responsible for my behaviour when using ICT because I know that these rules are to keep me safe
- ✓ I will support the school approach to online safety and not deliberately upload or add any images, video, sounds or text that could upset any member of the school community
- ✓ I know that my use of ICT can be checked and that my parent/carer will be contacted if a member of school staff is concerned about my eSafety
- ✓ I will not download files without permission from the teacher
